U.S. preferred stock market summary, ending October

CDx3-Compliant Preferreds: The average market price of the highest quality preferred stocks dropped by \$0.22 during October to \$26.20. That leaves us with an average current yield offered by these securities of 6.115%. For the quarter, the news was good for preferred stock buyers with the average market price of the highest quality issues dropping by \$0.24.

US-Traded Preferred Stocks: The average market price of call-protected US-traded preferred stocks and ETDs decreased by \$0.05 during October to \$24.56. Preferred stock investors are now being offered an average current yield of 6.822%. For the quarter ending October, the average market price of these securities rose by \$0.41.


Money Rates: The quarter was unkind to savers with the average 2-year CD APY falling 0.250% over the last three months, ending October at 0.760%.

Preferred Stock Insider Buying Report

Directors, officers, and large owners are all required to make form 4 filings with the SEC whenever they buy preferred shares in their company. We keep an eye out for those filings and report them here, presenting the most recent preferred stocks seeing insider buying activity. Note that sometimes the class of preferred stock purchased is not available to the public to buy, but the activity can still be noteworthy to observe, especially as an indicator to use in tandem with the CDx3 Perfect Market Index — if our index is flashing "buyer's market" and insiders are also on a buying spree, that is a great confirmation signal.

The above table lists the top ten call-protected movers by volume that offer Moody's investment grade ratings and a minimum 5.5 percent coupon at the end of October.

What was everyone else buying as October came to a close? Notice that almost all of these are ETDS' (baby bonds, always presented in green font) which rank senior to the same company's preferreds for dividend payments or bankruptcy.

Normal daily trading for a preferred stock is usually around 30,000 shares.

Our PSL database is the most powerful such tool available for preferred stock investors. By using PSL's preferred stock filter you can slice and dice the market using up to 25 characteristics of these securities. And once you get your list, you can narrow it even further by sorting and re-sorting or by removing unwanted rows while keeping others. You can hover your mouse pointer over various fields to get even more detail or click your mouse to drill down even further.

To see what other preferred stock investors are buying at any time, use PSL's Securities To View drop-down menu to select the 'All Preferreds and ETDS' option (lists the entire database). Then sort the list by the Volume column (click on the column heading twice to see the biggest movers on top of the list).

BDC Baby Bonds & Preferreds Toplists

As regulated investment companies ("RICs"), Business Development Companies ("BDCs") have built-in investor protections including a limit on leverage. With a requirement to invest primarily in private companies in the United States, BDCs were created in 1980 by Congress to encourage the flow of public equity capital to private U.S. businesses. BDCs also have a structural requirement to distribute 90% of taxable income to shareholders, much like Real Estate Investment Trusts (REITs). Many BDCs issue preferred stocks and exchange traded debt (ETD) securities also known as "baby bonds."
