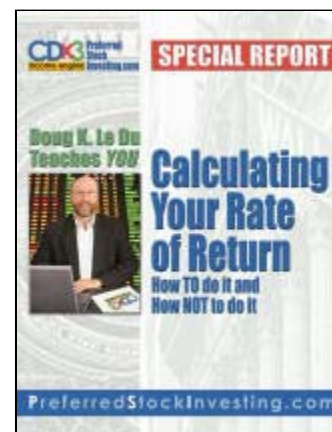

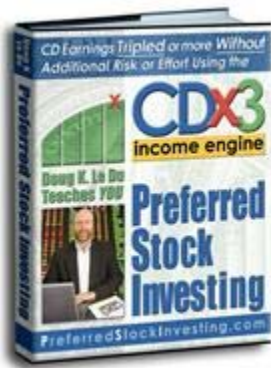
▶ **Next Month's Sneak Peek**
